- 12) Tenants agree that the Owners reserve the right to revoke permission to keep the pet should the Tenants break this agreement. Tenants will be given 3 days to remove the pet from the premises.
- 13) Any animals on the property not registered under this Rental Agreement will be presumed to be strays and will be disposed of according to law, at the option of the Landlord.
- 14) All litter boxes must be placed on a protective/plastic floor covering and maintained in a proper and sanitary condition.
- 15) Used litter will be double bagged and disposed in your outdoor trash receptacle and NOT disposed of down the toilet regardless of product's claim of "flushability."
- 16) Tenants may not abandon the pet or leave it for an extended period of time.
- 17) No "visiting" or temporary boarding of pets.
